#### 1949 - 1975

The Royal University of Law and Economics (RULE) is the first higher education institution in Cambodia. It was originally founded in 1949 as the National Institute of Law, and Economics, and then it was renamed as the Faculty of Law and Economic Sciences and integrated into the University of Phnom Penh in 1957.

#### 1975 - 1994

Unfortunately, the university was closed during the Khmer Rouge Regime (1975-1979), and re-opened in 1982 as the Administrative and Judicial School. In 1992, the School was renamed the Faculty of Law.

#### **1994 - 2003**

In 1994, it was named again as the Faculty of Law and Economics and integrated into the Royal University of Phnom Penh under the control of the Ministry of Education, Youth and Sport.

#### **2003 - PRESENT**

In 2003, the Faculty was re-organized as a university status and named the Royal University of Law and Economics (RULE). RULE became a public administrative institution by Sub-decree No. 89 ANK/BK dated July 27, 2007.


RULE currently has four faculties (the Faculty of Law, the Faculty of Public Administration, the Faculty of Economics and Management, and the Faculty of Informatic Economics), the Graduate Program, three centers (the Center of Law Research, the Center of Economics Research, and the Research and Education Center for Japanese law), and the English Language Institute.

### **FACULTY OF LAW**

#### **Bachelor of Laws (National Program)**

The Bachelor of law program at RULE is provided in the Khmer language. Students are expected to undertake a four year course, including one year in foundation year. The program was developed with the goal of providing students with a robust knowledge in different areas of law so as to equip students with the basic understanding of the legal framework in Cambodia. Furthermore, the program aims to equip them with analytical, negotiation and critical thinking skills. Over the years, students from RULE have been able to become law practitioners in reputed law firms as well as hold down positions in the government.

#### Bachelor of Laws (French Cooperation Program)



The French cooperation offers several classes: a Preparatory Class, a Bachelor (French "licence") in Law from Lyon 2 University (France) and some Master's degrees from Lyon 2, Lyon 3 and Paris 2 Universities. Since the Paris agreements' signature, France has contrived numerous tools of bilateral aid to rebuild Cambodia and reconstitute its elites. The Royal University of Law and Economics represents a milestone of this project on the rule of law reinforcement.

Present since 1992, the French cooperation's

main mission is to guarantee the excellence of its law programs and to maintain the institution with its expertise and know-how. The RULE keeps a prior partnership with the University Lumière Lyon 2 and University Panthéon-Assas Paris 2. This French branch, which currently gathers more than 200 Khmer students, enables them to participate to an overseas bachelor's degree from this French University. The overall activities of the cooperation office are led by a team composing of a project officer, an international volunteer, a French coordinator and an executive secretary.

#### **Preparatory Class (1st Year)**

This one-year program aims to prepare the student to enter the French "Licence" in Law from Lyon 2 University. All Courses are given in French language.

#### **Bachelor of laws from Lyon 2 University (France)**

Since 1998, the RULE offers a two year program with two diplomas:

- a French diploma, the bachelor in law of Lumière Lyon 2 University (this diploma from Lyon 2 University has the same value as if the student got it in France).
- a Khmer diploma, the bachelor of laws.

Courses are given by French professors from Lyon 2 University as well as by local professors (professionals, PhD students). Students are selected through an entrance test.



**Faculty Members**: As of June 2018, ELBBL has 7 full-time faculty members, 30 part-time lecturers, and over 280 students. The majority of ELBBL faculty members have advanced degrees (Masters or higher) from well-respected universities around the world.

**ELBBL** is working to achieve international law school standards by incorporating more interactive teaching methods in coursework, encouraging extracurricular activities, and developing measures for quality assurance purposes.

#### The Focus on Legal Research and Writing

ELBBL prioritizes students' ability to research, analyze, and write effective legal arguments through three classes. First, students are exposed to legal methods and reasoning to become familiar with deductive and inductive reasoning, case briefing, and legal argument making. Second, students learn about how to construct legal arguments using legal reasoning (deductive reasoning, inductive reasoning, and policy-based reasoning) and constructing legal memoranda. Third, students get to study about academic legal writing. In these classes, research and plagiarism are also emphasized.

These classes prepare students for moot programs, in which students are required to draft legal memorials on highly sophisticated cases with supervision of coaches. After these classes, students will become effective legal researchers and writers.

As part of ELBBL, the Center for the Study of Humanitarian Law (CSHL), supported by the Raoul Wallenberg Institute of Human Rights (RWI), produces research and provides related to trainings international humanitarian law, human rights, and fair trial standards. The Center provides RULE students with a practical research space, books and online resources (Westlaw database and the Oxford Journals).

Students can have access to the law library/e-research center, a hybrid of a computer lab, a law library (including elibrary), and a research center. Students will have a space and materials for conducting research. They can also participate in webinars and other similar online learning opportunities. ELBBL also have available study rooms for students.



#### The Focus on Moot Court Program

ELBBL students need practical experience to complement their coursework. ELBBL focuses on its moot court program to provide students with skills needed in today's legal world. ELBBL requires students to complete one moot court class and compete in at least one moot court competition during their studies. ELBBL students participate in any of the four prestigious international moot competitions:

- Philip C. Jessup International Law Moot Court Competition, held in Washington D.C., USA;
- Willem C. Vis International Commercial Arbitration Moot, held in Vienna, Austria;
- Willem C. Vis East International Commercial Arbitration Moot, held in Hong Kong, China;
- Red Cross International Humanitarian Law Moot Competition, held in Hong Kong, China;
- Jean-Pictet Competition in International Humanitarian Law, held this year in Macedonia;
- Nelson Mandela World Human Rights Moot Court Competition, held in Geneva, Switzerland;
- 7. Nuremberg Moot Court Competition, held in Nuremberg, Germany.





In 2018, the team from ELBBL representing RULE and Cambodia has obtained two achievements at the international stage of the Philip C. Jessup International Law Moot Court Competition. First, the team's memorials won 12<sup>th</sup> Place in the Best Combined Memorial Award. Second, the team's applicant memorial won 3<sup>rd</sup> Place in the Best Applicant Memorial Award.

"Each year, ELBBL's moot teams compete against the best law schools from around the world. Teams from ELBBL have gained numerous international accolades at these international moot court competitions, including the 2<sup>nd</sup> Best Combined Memorial Award and the Octo-Finalist Award (Top 16) out of over 500 law schools at the Jessup Competition. #### Student Exchange Opportunities

There are several exchange opportunities that ELBBL students are eligible to apply. Each year, several ELBBL students go on exchange programs at Nagoya University in Japan, National University of Singapore in Singapore, Nanyang Technological University in Singapore, East China University of Political Science and Law in China, and University of Airlangga in Indonesia. ELBBL also accommodate a few incoming exchange students from Nagoya University. Students spend a term (range from a few weeks to several months) abroad studying laws and experience a greater cross-cultural learning environment.



#### National and Regional Competitions and Events

ELBBL students are encouraged to participate in various national competitions/events to expand their collaborative technical knowledge, as well as research and advocacy skills. ELBBL's faculty members often assisted students in the preparation of such events on a volunteer basis. Recent competitions that ELBBL students have participated (with result) include:

#### Extra-curricular Activities

ELBBL students participate in a variety of extra-curricular activities. ELBBL and CSHL organize short courses, workshops, and seminars instructed by professors and lawyers from around the world, especially on topics related to international law. They also arrange field trips for students to visit the Extraordinary Chambers in the Court of Cambodia to follow the case proceedings.

In addition, the Cambodian International Law Student Association Chapter (Cambodian ILSA), an independent student-run association registered under ILSA in the U.S., which serves as its umbrella organization, organizes moot court trainings, scholarship workshops, musical parties, and field studies. These activities allow students to sharpen their legal knowledge and advocacy skills, building networks, and have fun.



#### Student Scholarship and Career Services

ELBBL also boasts a highly effective scholarship and career consultation service. With an experienced staff member, ELBBL supports its students in finding internships, assists with scholarship application procedures, works with graduates to locate professional opportunities, and holds resume-writing workshops and mock interviews.

Over one-fifth of all ELBBL graduates have pursued advanced law degrees at well-respected universities in, among others, Korea, Japan, Singapore, Sweden, United States, and United Kingdom. Most of these graduates receive full or partial scholarships funded by foreign governments of the admitting universities due to their excellent academic performance and practical experience. Many of the ELBBL graduates also obtain internships and employment at public institutions, NGOs, and top law firms in Cambodia.

#### The Center for the Study of Humanitarian Law

Established in 2014, the Center for the Study of Humanitarian Law (the **Center**) is an academic research center that focuses on research on, promotion of, and education about international humanitarian law and human rights. It is the only university-based research center of its kind in Cambodia and employs leading researchers in the fields of international humanitarian law, human rights and criminal justice. The Center also has a library containing a wide variety of hard copy texts and electronic resources, especially Westlaw and Oxford Journal, which are available to Center staff, students of the university and the general public more broadly.



The Center is affiliated with the English Language Based Bachelor of Law (**ELBBL**) program at the Royal University of Law and Economics (**RULE**). It is supported by the Raoul Wallenberg Institute, RULE, and the International Committee of the Red Cross (**ICRC**).

The Center's library is open from 8AM-5PM (Mon-Fri).

- Publication of a Khmer version of the Nuremberg Academy's two book chapters on "Understanding Acceptance of International Justice through Duch's Sentence at the Extraordinay Chambers in the Courts of Cambodia" By Soy Kimsan and "Prosecuting the Khmer Rouge: Views from the Inside" by Ly Ratana,
- Signing a one-year research agreement with the Philipps-Universität Marburg, Germany, to implement a research project on "Victimhood after Mass Violence. How Victim Participation at the ECCC and Other Dealing with the Past Projects Effect Justice (VaM)",
- Signing a three-years research agreement with the Graduate Institute-Geneva, Switzerland, to implement the Demeter Project on "Gendered Agrarian Transformation and the Right to Food", and
- Completion of 6 working papers on children's rights in criminal proceedings, crowd management, labor law and construction workers, sustainable peace, migrant workers, and criminal justice.

#### International Exchange Programs

RULE takes part in the European Commission's Horizon 2020 Marie Sklodowska-Curie Actions programme Research and Innovation Staff Exchange project, "Institutions for Knowledge Intensive Development: economic and Regulatory Aspects in South-East Asian Transition Economies". The project implementation is led by Tallinn University of Technology in Estonia, with RULE, through the support of the Center, participating as one of the partner universities from South-East Asian including Laos and Vietnam. The objective of the H2020 project is to develop professional networking, research abilities, knowledge and skills of researchers and faculty members from partner universities, including RULE.

#### Teaching, Training Courses, and Moot Competitions

For several years, staff of the Center have made a significant contribution to the ELBBL program by teaching various subjects, including Advanced Criminal Procedure, Human Rights, and International Humanitarian Law. At the same time, staff will develop standard curricula for their courses to standardise the contents of these subjects. This will ensure that ELBBL students continue to receive the highest quality education, thereby ensuring that the reputation of graduates of the program continues to grow.

Alongside presenting on certain current issues at ad hoc conferences, the Center staff have regularly run training on human rights and humanitarian law to court clerks and students at the Royal Academy of Judicial Professions, members of the Cambodian military, and lecturers and students at universities in Phnom Penh and various provincial locations.

Trained and coached by Ms. Hing Vandanet, the Center's researcher funded by ICRC, RULE moot teams were awarded the national champion, runner-up, best memos and best oralist against their competitors from other school for 2017 National Round of International Humanitarian Law Moot Court Competition, organized by ICRC. The winning team will represent RULE and Cambodia in the international round held in Hong Kong in March 2018. Moreover, the Center supports RULE and ELBBL to coach, train and send three law students to participate in the Nelson Mandela World Human Rights Moot Court Competition held annually in Geneva, Swtizerland.



By promoting moot court competitions, the Center enables students to develop fundamental legal skills that they will require upon graduation: legal research and analysis; argumentation skills; and the ability to clearly articulate legal arguments, both orally and in writing.

#### Professional Legal Skills and Clinical Legal Education

Since 2015, the Center has supported a professional legal skills course (PLS, which is an integral part of the Center's clinical legal education (CLE) program for ELBBL students. This course, which was taught by a practising lawyer, provided students with the practical skills that are necessary for a successful career as a lawyer. The PLS course will enable students to will obtain not only legal knowledge, but they will also obtain the necessary skills to apply this knowledge in a competent and confident manner. At the same time, students will learn about legal ethics and the professional responsibilities of legal professional as well as get in touch with grass roots community organisations – which in turn builds in students a sense of value in applying their legal knowledge. On completing the PLS course, at least three students will be therefore selected to undertake paid internships at professional legal institutions and organization. The PLS course is therefore designed as a bridging course to prepare law students in their final year for joining the workforce in professional legal careers and to strengthen support for access to justice and rule of law in Cambodia.

**Other Initiatives:** In 2016, the Center began publishing its own monthly newsletter. This newsletter was promoted on the Center's Facebook page and being pinned on the Center's noticeboard. The purpose of the newsletter is to give students general information, such as the Center's upcoming events, but it also focuses each month on a particular current human rights or humanitarian law issue, with Center researchers writing a brief article about a current event or legal issue. Students may also be given the opportunity to submit articles for publication in the newsletter, in order to develop their legal analysis and writing skills.

### FACULTY OF PUBLIC ADMINISTRATION

#### **Bachelor of Public Administration**

The Bachelor of Public Administration is a four year program and the curriculum is taught in Khmer language. The courses are provided in order to provide students with the understanding of how the government functions and the implementation of government policies. With this in-dept knowledge, students will be able to develop problem solving skills and learn to apply it to the community. Students wishing to pursue a future career in the government sector or non-governmental organisations (NGOs) are encouraged to apply for the course.

At the time there were only those two front buildings and salle B, and the canteen was a little shack in the back. The school flooded often, so we didn't have class a lot. I think that back then the students were more eager and motivated than students are now. They thought that their future was

determined by learning English.

"I taught again at RULE in 2004-2006. Then we were teaching listing and speaking to first year students, and writing to second year students. The school had expanded a bit and students were very eager then as well. Teachers were also really respected and students were hungry to learn English. They saw that if they didn't learn English they weren't going to get a good job. In recent years, I would say students aren't as motivated. There are some that are very motivated in our classes, but Foundation year is different. Students have a different mindset something like, "Yes English will help me get a job, but I already know a lot, so I don't really know if I need you [the teacher]."

Joey Garcia has been teaching at RULE for the past five years, and currently is in charge of the ELIC teachers on campus. When asked about the relationship between RULE and ELIC, and

teaching Khmer students this is what he has to say:

"RULE and ELIC have been working closely for over 17 years to provide students with quality English teaching. RULE provides ELIC teachers with the materials and environment they need to teach and serve students to the best of their abilities. They are friendly and quick to assist in any way they can. Currently, apart from the courses they teach, ELIC offers outside help and opportunity for learning to students in a variety of forms. They provide an English conversation club where students can practice talking about different topics, gaining confidence and working on pronunciation and vocab use. They also provide a newspaper club where students are exposed to journalistic writing, embrace the process of



writing an article, and publish a student-driven English newspaper. They further host events such as English Night Live, Christmas Jubilee, and the Annual Public Speaking Competition. Through these clubs and events, ELIC hopes to foster an environment of learning, promote academic excellence, and build learner community and identity.

"My favorite thing about teaching Khmer students is their motivation. Over the past four years, I have met some incredible students with ambition and passion. These students come from many different backgrounds each with unique backgrounds. Some have faced hardships, some are overcoming difficulties, and some are hungry for the future. They bring this energy and hope into class. They recognize that learning happens both inside and outside the classroom. They take what they learn and they practice it, above and beyond expectation.

They pursue further opportunities to grow through seminars, conferences, clubs, and research. They understand the important role their education plays in their future, their family's future, and their countries future. They are humble, warm, beautiful people and they are inspiring."

## **Hear From Our Students**

We asked our students what it was like to study with a native English speaker, and how they would describe the experience to someone who has never studied with a native speaker. This is what several students had to say:

"Studying with a native speakers is the best way to learn the language. Native speakers not only teach and explain something really clearly to us, but also show us how to use it. They use a lot of activities that might seem strange, but they are fun and let us learn well. There is also a cultural difference, that we can learn from and use to interact with other foreigners. A native speaker is able to tell me what my mistakes are and how to best fix them. Native speakers teach differently. They have rules and lesson plans. They teach very clearly, and make it easy to understand. They have standards like no cheating, no discussing or looking around during the exam. We [the students] respect them because they will enforce their rules.

"Native speakers are prepared to teach their students and they create a different atmosphere in the class. There are more activities in the class. We work with partners or different



people the class rather than on our own. We do more teamwork based activities. Even the homework we have. While it might be a lot, it is given to help improve our ability to study English. It is hard for the first time, but you will get use to it. Also it will improve your speaking, so if you start starting with a native speaker it will affect your future. Experience it now, to help prepare for your future."

Goal, Mission and Vision

#### 1. Purpose

Include Japanese Language, which has been supported by JICA, Japan Foundation (J.F), and RULES, in the university curriculum like English and French. Create bachelor's degree of Japanese in commerce (3-4years) and graduate program for those who wish to pursue their study in Japan in the future.

#### 2. Goal

-Learners are able to gain inside into Japanese language, culture and use the language for daily conversation and trade.

-Learners will be able to us the language trained at RULES to pursue their study in Japan or communicate with Japanese citizens or other students in Nagoya, Saga, Kyoto, Kobe, Waseda, or Meiji universities ... ect.

-With Japanese language learnt from the university, learners can apply for jobs in Japanese organizations, Japanese commercial companies, translation companies, or Japanese teaching institutions.

-set up Japanese language training course to prepare learners for Suzuka university admission or Tokyo Japanese Language center, Aoyama Japanese Language School for school fee program (50% off for Cambodian students).

-Japan Human Power (JHP) suggests Japanese language office to create exchange program for Cambodian and Japanese students every year. Thus, the office is going to sign a contract on exchange program with related partners.

-To strengthen the intimate relationship between students who are learning Japanese language and JICA, Japanese Language Office has created a study tour to JICA office for them to study the development of the organization and gain some vital experiences for future use.

-To provide more alternatives to learners of Japanese language, the office is planning to run evening shift classes, but the fee is a bit more expensive than morning and afternoon shifts.

-To fulfill today's job markets that require staffs with good command of Japanese, the office has set up a 2-year study program for bachelor degree students.

#### 3. Mission

To accomplish our goal and vision, Japanese Language Office which has been sponsored by Royal University of Law and Economics since 2002 has been doing the followings:

#### 5. Japanese language graduates


Since 2002, Japanese language graduates have been employed as lecturers at Royal University of Phnom Penh, staffs at other research centers and Japanese law education, teacher at private Japanese schools, JICA staffs, teachers of Japanese in Laotian organizations, staffs in Japanese banks and companies, and tour guides. The mission of the Research and Education Center for Japanese Law (CJL) is to nurture specialists with an understanding in Japan's society, culture, language, and law in an organized and sustained environment.

Step 1 : Japanese Language Training

Japanese Law and Language education is provided in parallel with the regular course at the host university.

Firstly, students commence Japanese language education on entry into the undergraduate program of the host university. In accordance with the curriculum of the host university, students aim at passing JLPT N1 or N2 in 4 or 5 years. These classes are conducted by Japanese language lecturers. Step 2 : Introductory Japanese Law

The Students then participate in undertake classes of Japanese Law in the Japanese Language. Students take classes based on video lectures by law professors in Japan and moderated by in-country lecturers. Students also take schooling seminars a few times in each year, which aim at providing students with an overall understanding of the structure and characteristics of Japanese Law.


Furthermore, through the participation in the Summer Seminar held at Nagoya University, the students are given the opportunity to experience Japanese society first-hand. Step 3 : Study at Nagoya University

Students who have completed the coursework of the center are then selected according to their achievements, to study at Nagoya University's Graduate School of Law to be trained as researchers and specialists in Japanese Law.

Nagoya University is striving to become a sustained and institutionalized base for the nurturing of specialists with good knowledge and understanding of the Japanese language and Japanese Law.



# **QUALITY ASSURANCE OFFICE**

### History



Internal Quality Assurance Unit (IQA) started with the assignment letter of officers in charge of quality assurance in education in 2004. In 2007 and 2013, RULE was assessed by the Accreditation Committee of Cambodia (ACC) for the Foundation Year Program and awarded the Accreditation Certificate. In 2015, ACC conducted the pilot institutional assessment.

Remarkably, in 2012, RULE has assigned the self-assessment report committee to write the SAR for the program assessment of Bachelor of Economics in Management, which was conducted in 2013 by ASEAN Universities Network (AUN) under cooperation from European Union.

In July 2015, RULE assigned the person in charge of Quality Assurance and directly reported to the Rector. From August 2017, Quality Assurance Office (QAO) was formally established and played an important role in internal quality assurance at RULE.

### **Objectives**

Following the university's vision and mission, QAO supports continuous improvement of quality education for the whole university.

### Activities

In 2016, RULE has set up the criteria for the internal assessors. The call for application was made from December 2016 to January 2017 and then final interview was conducted by Recruitment Committee for Internal Assessors in March 2017. Finally, 12 Internal Assessors successfully appointed.

In March 2018, the first internal assessor training was made in cooperation with ACC and the Royal University of Phnom Penh.

# **STUDENTS AND FACULTY MEMBERS**

In the academic year 2017-2018, there are totally 13,213 students in which 6,527 are female, studying at RULE. Among them 12,080 are Bachelor students (6,170 female), and 1,133 are Master students (357 female). Among Bachelor students, 1,298 students are scholarship students (811 female).

One of the outstanding features of RULE is the large pool of highly qualified teaching and administrative staff. There are 103 full-time staff (24 female), 63 contracting staff (24 female), 314 visiting lecturers (61 female) and 93 foreign lecturers (32 female), who give lectures under the academic programs. These allow students to learn from a huge body of knowledge.

# **RESOURCES AND FACILITIES**

# **LOCATION**

RULE is located along Monivong Boulevard, which is convenient for students to commute to the university. The campus is large, clean and well landscaped. Buildings and classrooms have been renovated to be more suitable to the students' needs as well as current technological advances.







# LIBRARY

In newly-constructed Building I, the libraries are available at the second floor for Law, the third floor for Economics, and the fourth floor for electronic resources named E-Library. Each library consists of around 200 seats. E-Library has 84 computers for students, faculty members and researchers to use.

The libraries are equipped with new furniture, bright and colorful book shelves. Currently, approximately 20,000 books and other reading resources in Khmer, English and French are available at the newly built libraries.



The Library Management System (LMS) is KOHA. This LMS is an integrated all library functions for librarians, and students to access OPAC via web base: www.opac.libraryrule. com.

Electronic resources cover full-texts and reference materials available through subscriptions and free online access. The library is implementing Repository Service using DSpace which is an open source repository software package.

# **COMPUTER LABS, INTERNET ACCESS AND CONFERENCE HALLS**

Our computer labs provide students with the opportunity to communicate and explore the vast amount of information around the world. There are five large conference halls to serve various functions such as national and international seminars and workshops.

# **RESEARCH CENTERS**

RULE places more attention on academic research activities and expanded its emphasis on education towards research orientation. Three research centers were established, the Research Center of Law, the Research Center of Economics, and the Research and Education Center for Japanese Law. 1. For admission into the Bachelor's programs at RULE, prospective students are required to possess a high school diploma or an equivalent.


2. For admission into the Master's programs at RULE, students are required to meet one of the following criteria:
